### 3. Competition rules

#### 3.1 Rules

1. The EPZ Omloop van Borsele, hereinafter referred to as "the contest" is on Friday 21 April 2023 organized by “Stichting Wielercomité 's-Heerenhoek”, hereinafter referred to as the Cycling Foundation Committee organization. The Foundation is also holder of listed race license. (KNWU) and the permits and exemptions from Governments. Available for inspection at the modest are named after Secretary of the organization.
2. The contest is held under the auspices and in accordance with the regulations, annual decisions by the UCI and the KNWU.
3. The participants-riders are supposed to be aware of:
  - the regulations, provisions and instructions of the UCI, the KNWU and the organization;
  - the route to follow
4. The contest is held in accordance with the rules of the time trial races: Junior-Women, Elite Women.
5. The presentation of the numbers has place in Spek mie Stroop, Marktstraat 16 (tel: 0113-351717).
6. The Time Trial will be driven without transponders.
7. Dressing and washing facilities are located in the locker accommodation of the Sports Hall (see description elsewhere in this scenario.)
8. The jury meeting will take place at Pannenkoekhuis Spek mie Stroop situated at: Marktstraat 16 (tel: 0113-351717).
9. The final lists of participants-riders are available at the Permanence from 30 minutes prior to the departure.
10. The participants-riders introduce themselves on the Heerenstraat on and follow the instructions of the speaker
11. The start will take place on Friday 24<sup>th</sup> of April for the elite women at 19.20 hours
12. The participants-riders are required to be present at least 15 minutes before the start, and issued by the organization with clearly visible and regulatory-applied numbers.
13. As far as competent the trailers prepare at the Heerenstraat behind the riders. The transport in these follower cars by non-official persons or vehicles is prohibited. They will be removed, where appropriate, after consultation.
14. On points, which could endanger will be placed by the organization persons with a yellow flag. The riders need at these points extreme attention and exercise caution.

15. The participants and their escorts are required by the Organization, all indications of police jury appointed officials and employees to follow. Ignoring these instructions will at least lead to a start prohibition or exclusion of the contest.

16. The Organization considers itself not responsible for losing materials etc.

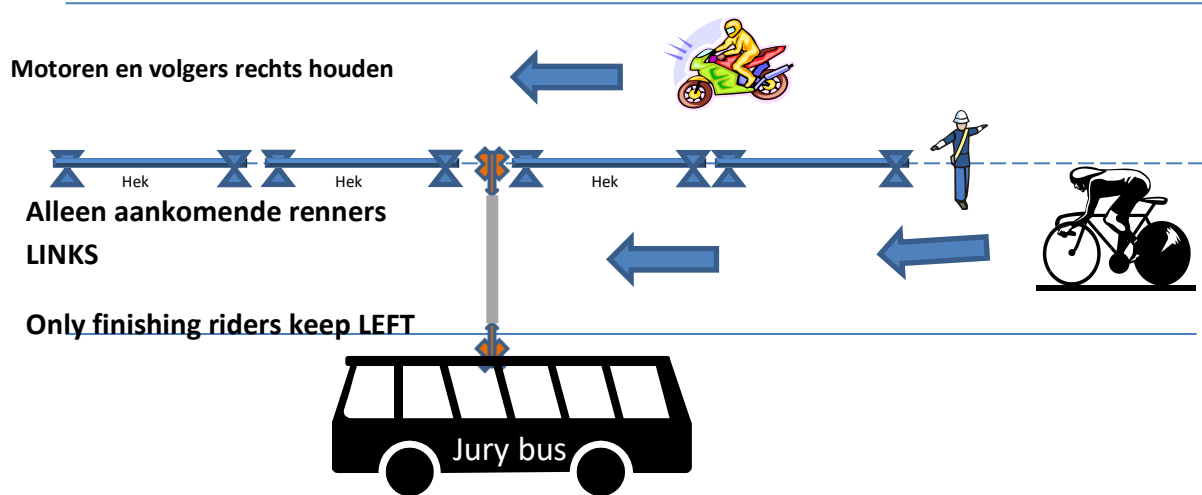

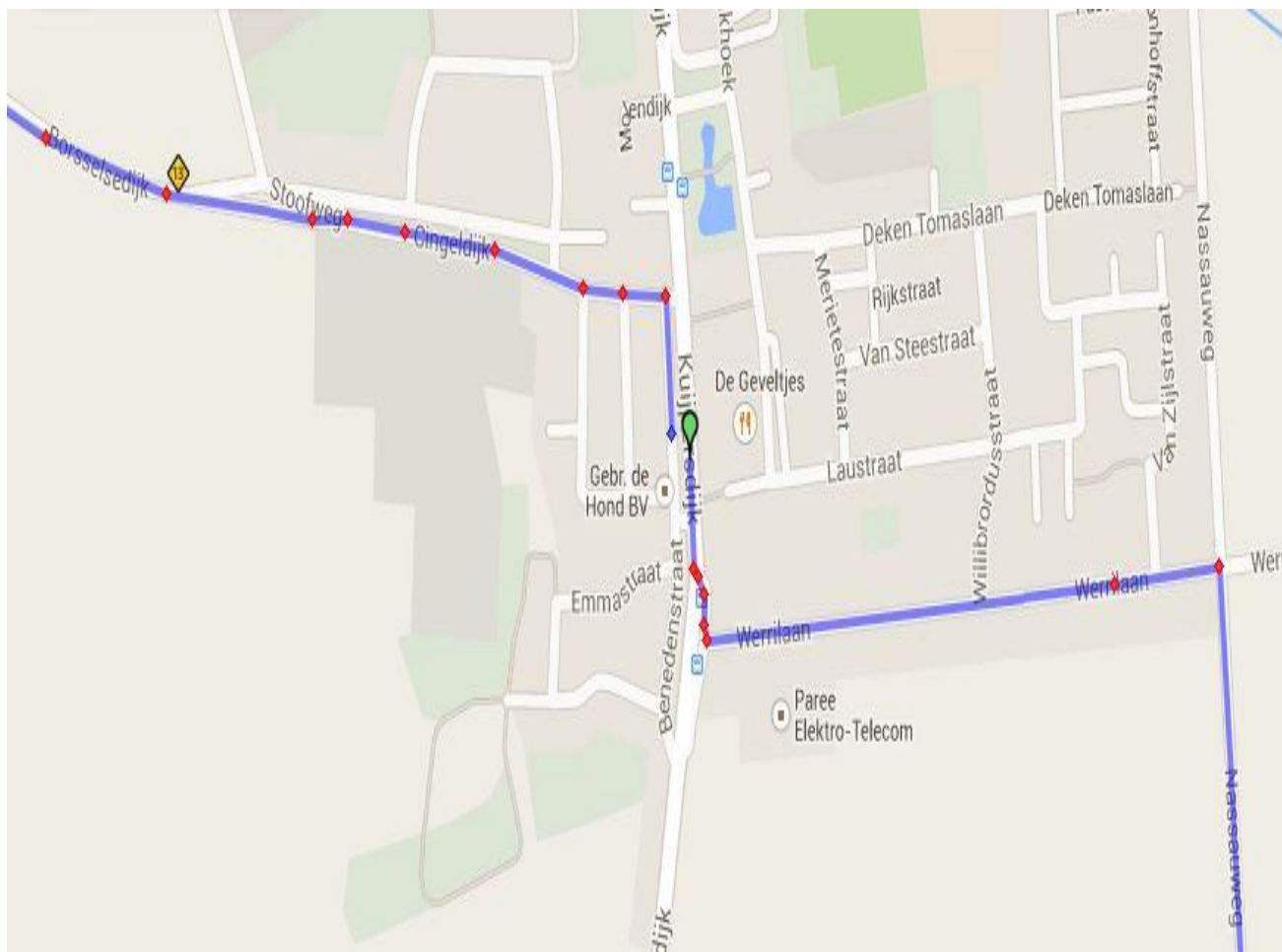
